We the 'Sharia Supervisory Committee' for Al Rayan Bank PLC confirm that in our opinion the **12 Months Fixed Term Deposit Cash ISA Account** is in accordance with the Wakala Principle of Islamic Finance. Wakala is an agency agreement for investment, whereas the Bank acts as the customer's agent (*Wakeel*) to invest the funds, in Sharia compliant activities, and to achieve an expected rate of profit. Profit is then paid to customers free of any deduction of income tax, in accordance with the ISA regulations and the terms and conditions of the account. Therefore, we allow the Bank to provide this product to its customers.

Cash ISA (Individual Savings Account) is a savings product that allows a UK resident to invest up to a set total limit in each tax year (6th April to 5th April), with the profit received as a result of this investment being tax free.
