<sup>3</sup> Where profit is reinvested and paid on maturity, the annual equivalent expected profit rates will be: 0.65% on the 12 month FTD ISA, 0.75% on the 24 month FTD ISA (for new customers for 1 March only) and 0.65% on the 12 month FTD, 0.70% on the 18 month FTD, 0.80% on the 24 month FTD and 0.95% on the 36 month FTD (up to and inclusive of 18<sup>th</sup> March). From 19<sup>th</sup> March onwards: 0.55% on the 12 month FTD, 0.60% on the 18 month FTD, 0.65% on the 24 month FTD and 0.90% on the 36 month FTD.

The expected profit rates above may be subject to change due to potential volatility in Commodity Murabaha markets. Al Rayan Bank will notify you of any changes as soon as practically possible. The profit distribution target rate quoted refers to the actual payment you may receive and is "before tax". As you will see from the paragraph below, your effective "after tax" return will vary depending on your individual circumstances.

### Tax treatment of the profit share

### Individual account holders

Since 6 April 2016 all banks and building societies are no longer required to deduct tax from the savings returns you earn. If you are a basic or higher rate tax payer, you have an annual Personal Savings Allowance (PSA), allowing you to earn profit tax-free. However, once you reach your PSA limit, you will be required to pay tax on your profit. The PSA excludes ISAs, which continue to be tax-free for eligible customers.

The profit earned on a savings account is classed as income. Savers currently pay tax on this income, based on their income tax bracket. Under PSA basic rate taxpayers (20%) will be able to earn £1,000 in savings tax-free, whilst higher rate tax payers (40%) will receive a £500 allowance. Additional rate (45%) taxpayers will not receive any allowance.

Any savings returns you earn above your Personal Savings Allowance are subject to UK tax and it will be your responsibility to declare this to HM Revenue & Customs. Please note

this applies to the total savings returns you earn from all the banks and building societies, not just Al Rayan Bank. You can find out more about PSA on [gov.uk](https://www.gov.uk). **Account holders who are companies within the charge to corporation tax**

For the purposes of UK tax law, the profit share you receive is treated as a return on a loan equivalent to the amount deposited with Al Rayan Bank, and is taxed as if it were a return on a loan relationship under Chapter 2 of Part 4 Finance Act 1996.
